LOCATION: Port of Redwood City turning basins.

ELIGIBILITY: Any PCISA, ISSA School may enter. Multiple teams from a school permitted.

ENTRY FEE: \$35 per sailor. Entry fee includes racing, meals (see meals below) and awards. Please make checks payable to PYSF. Payable at check in Sat morning.

BOATS: Each team is responsible for providing one class legal CFJ and sails for the event. Bow Numbers may be used

RULES: The regatta will be governed by the Racing Rules of Sailing (RRS) for 2004-2008, the Prescriptions of US Sailing, this Notice of Race (except as any of these are changed by the Sailing Instructions); and by the Sailing Instructions.

FORMAT: Races will be sailed using an A and B Division team from each high school. High schools without a complete team may be combined if possible, Two or more sailors from a given school must compete as a team. Slash teams will be allowed.

Rotation: This will be team rotation event. "A" and "B" divisions will rotate into the boat they brought. (Boats will not be rotated). ie. 1 boat = 4 sailors.
