**RULES**

The regatta will be governed by the 2004-2008 Racing Rule of Sailing (RRS), the prescriptions of US SAILING, Team Racing Rules (Appendix D), by the USTRA and ISSA/PCISA rules except as any of these are altered by this Notice of Race, or by the Sailing instructions.

Entries will be limited to the first 9 teams. Either by Faxed entry form or online. Entry fee \$150 per team of 6 (\$25 per sailor) + \$10.00 per alternate, Checks payable to the Peninsula Youth Sailing Foundation, (PYSF) May be paid at check in Sun. morning.

Includes lunch and Continental Breakfast.

**TEAMS**

Each competing team shall consist of three skippers, three crews and three boats. Teams are free to bring alternates which may be substituted between races. Schools may mix and match sailors. Teams must enter a team name. (You may use your schools Mascot)

**BOATS**

The regatta will be sailed using class legal Club Flying Juniors (CFJ's). This will be a bring your own boats regatta. Each team will bring Two boats. 18 boat rotation format. This may be modified during registration period.

**SAILING INSTRUCTIONS**

Sailing Instructions will be available upon registration at the public launch.

## FORMAT

Subject to weather conditions, competitors will engage in a continuous round robin with no limit to the number of races. Coaches may be asked to compete in the last races. Bring your sailing gear.

## RACING AREA AND COURSE

A digital N, Triangle Or Modified N will be set in Turning Basin

## SCORING

Scoring will be in accordance with Appendix D, except as modified by the Sailing Instructions.

## COACHING

Coaching will be allowed between races, on and off the water.

## PROTESTS

Races will be officiated by the competitors and by on the water judging by selected regatta personnel.

A coach or committee of coaches will hear protests not covered by competitor exoneration or by on the water judging as soon as possible. Protests will be determined by "3 minute justice", each competitor having "60 seconds" to present her/his position to Protest committee with the decision coming immediately thereafter.

Decisions made by on the water judges and by 3 minute justice are final.

## Awards

Awards will be given to the top three teams. 6 per place. (1st 2nd 3rd)
